# **ACTIVITY REPORT (2020-21**

Dear Members

I am extremely honoured and assure you all of my best efforts to do justice with this highly respectable post.

I am pleased to present before you all the "Activity Report" of the Executive Committee 2020-21 for the 1st Half of the Year, although

it would be incorrect to call this period the "1st Half" because as you all know, this committee was formed in October 2020 only. In fact, in the month of October also, this committee could actually take charge only after 12th October because the working of this committee had been put on hold by the Tribunal, following a complaint filed against the Election Process by few of our members. So, practically there have been only Two and Half Months to work in the 1st half of the year, and I shall share with you all a gist of the activities conducted during these 2 and 1/2 months

### 1) Meetings with Government Departments / Officials etc.

During this short span of 2 and 1/2 months, the Office Bearers and Executive Members have attended several meetings with several government officials / departments

a) Webinar on Safety & Protection of Children on Streets: A Webinar on the topic "Safety & Protection of Children on Streets" was attended at DC, Sonitpur's Office on 14/10/2020 by the President Shri Sunil Patni and Sr. vice President Shri Surendra Agarwal

b) Introductory Meeting with DC Sonitpur: An Introductory Meeting of the newly elected Office Bearers along with the PRO, Shri Nilesh Aagrwal was held with Deputy Commissioner Sonitpur, Shri Manvendra Pratap Singh, at his Residence Camp Office on 17/10/2020. Various issues like cleanliness, working of the Municipality, Airlines, Roads etc. were discussed with him.



c) Introductory Meeting with Sonitpur: Office Bearers of NACCI, along with the PRO and Municipal Sub-Committee Chairr Shri Paras Nath Ray, met Shri Mugdhojyoti Dev Mahanta, Superintendent of Police, Sonitpur, at his Office on 31/10/2020. Matters of public concern like Parking, general traffic conditions, rationalization of No Entry points in the town were discussed with him



- d) Meeting on PMSVAN Nidhi at TMB Office: President, Hony. Secretary Shri Ramesh Kr. Garodia and Chairman of Municipal Sub-Committee attended a Meeting on the "Pradhan Mantri Street Vendor Atma Nirbhar Nidhi" Yojana at the Office of the Tezpur Municipal Board on 09/11/2020. Under this Scheme, government if providing loans of upto Rs. 10,000/- at a very subsidized interest rate, without any major
- e) Virtual Meeting with FICCI: A Virtual Meeting was held by our Executive Committee Members with the Officials of FICCI on 28/11/2020, FICCI Officials gave a brief presentation on the upcoming Annual Expo of FICCI which is going to be hosted by FICCI on a Virtual Platform. President and our members requested FICCI for coming up with incentives to enable our members and small vendors to join the Expo as Exhibitors as the regular charges being charged by FICCI were very high and it was highly unlikely that our members would be able to join the Expo at such prices
- f) Meeting with GM, DICC: A Meeting was held by our President along with the Addl. Secretary and Chairman of Industries Sub-Committee, Shri Jatinder Sharma, and Committee members Shri Rahul Baid & Shri Adarsh Tibrewal with the General manager District industries & Commerce Centre, Tezpur, on 01/12/2020 to discuss on the issues being faced by the Industries in the District. Means and ways to promote the setting up of new industries were also discussed
- g) Meeting with the DCT, Tezpur: Chairman of Taxation Sub Committee & Treasurer, Shri Rajesh Daga, along with the Sr. Vice President and Vice President Shri Anup Jalan, met the Deputy Commissioner of Taxes Tezpur, Shri Anil Jalan, at his office on 04/12/2020. It was decided to hold a Camp for Registration and Collection of Professional Tax at NACCI Office. It was also discussed on how better compliance of GST filing could be done by members and on the problems being faced by the Members on various aspects of GST.

Municipality h) Meeting with Chairperson: President, along with Sr. Vice President and Chairman, Municipal Sub-Committee, met the Chairperson of Tezpur Municipal Board, Smt Antarita Daimari, ADC, along with other officers on 07/12/2020. Several issues of public interest were discussed in the meeting



#### 2) Emergency Helpline

During this short span of 2 and 1/2 Months, NACCI's Emergency Helpline received distress calls from 2 of its members

a)Sanjay PCO & Stores: A Call was received by President regarding some trouble being caused by some youth at the Sanjay PCO & Stores, Main Road. President, along with Shri Dipender Joshi, Helpline Chairman immediately reached the spot and helped in

b) Kettle Café: Another distress call was received by the Emergency Helpline Committee on 29/10/2020 from Shri Abhinav Dugar. It was informed that due to the café being closed during the lockdown, some miscreants had forcefully taken possession of the said property and had also grabbed lot of belongings of the café. The matter was immediately taken up by the Emergency Helpline Sub-Committee. An Emergency Meeting of the Sub Committee was called on 02/11/2020 to discuss on the issue. A Delegation of NACCI containing around 30 Members met the DC Sonitpur on 03/11/2020 and handed over a Representation requesting him to intervene in the matter and take steps to restore possession of the property to Shri Abhinav Dugar immediately. The DC assured to take the best possible steps at the earliest

c) Another complaint was received from the members from LDS Road (Garwany Patty) area regarding the trouble being faced by them because of blockage of major portion of the road due to the construction materials lying on the road since last many days for widening of the road. The matter was immediately taken up by the President with the concerned authorities and within a span of 1 week the widening work of the road was completed and the road was cleared.

#### 3) Condolence for Former CM Late Tarun Gogoi

A Condolence was organized on 26/11/2020 at NACCI Office to enable the members of NACCI to pay tributes to the Former Chief Minister of Assam, Late Tarun Gogoi, Several Executive and General Members of NACCI attended the same and paid tributes to the great departed leader.



# "Weights & Measurement" Camp:

A "3-Days Camp for Re-Verification of Weights & Measurement Instruments" was held at NACCI Office from 14/12/2020 to 16/12/2020. Officials of the Department of Legal Metrology did the alignment and stamping of the Weights & Measurement instruments of the members who visited the Camp. Around 150 Members took the benefit of the camp and got their instruments aligned and stamped.



A "Job Mela" was organized by NACCI in association with "Assured Consultancy Services" at NACCI Bhawan on 19/12/2020 under the Chairman, Employment Helpline Sub-Committee Shri Madan Joshi and Dy. Secretary & Convener, Shri Rajiv Jain (Jain Computers). It was a very successful camp with more than 70 candidates and around 20 companies



participating in the Camp. The Participating Companies as well as the candidates highly appreciated the format of the Fair and requested for such events to be organized regularly. The actual conversion figures were not available till the time of compilation of this report but It is expected that at least 25-30 candidates would actually be hired on the basis of the interviews taken in this camp.

#### Quarterly Return Filing and Monthly Payment of Taxes (QRMP) Scheme under GST

The Central Board of Indirect Taxes & Customs (CBIC) introduced Quarterly Return Filing and Monthly Payment of Taxes (QRMP) scheme under Goods and Services Tax (GST) to help small taxpayers whose turnover is less than Rs.5 crores. The QRMP scheme allows the taxpayers to file GSTR-3B on a quarterly basis and pay tax every month.

# 1. Who is eligible for the QRMP scheme?

A registered person who is required to furnish a return in FORM GSTR-3B, and who has an aggregate turnover of up to 5 crore rupees in the preceding financial year, is eligible for the QRMP Scheme. Further, in case the aggregate turnover exceeds five crore rupees during any quarter in the current financial year, the registered person shall not be eligible for the scheme from the next quarter.

The quarterly GSTR-3B filing option will be available from 1st January 2021 onwards. It is clarified that this scheme is optional and can be availed based on GSTIN.

## 2. How to exercise Option for QRMP Scheme?

A registered person who intends to file his GSTR-3B quarterly should indicate the same on GST portal, from the 1st of the second month of the preceding quarter until the last day of the first month of the quarter for which such option is being exercised.

For example: If A wishes to file quarterly returns for the quarter of Jan-Mar 2021, he should opt for quarterly filing on the common GST portal between 1st November 2020 and 31st January 2021.

Once the registered person has opted for quarterly filing, he will have to continue to furnish his return every quarter for all future tax periods, except in the following situations:

1. If the taxpayer becomes ineligible for furnishing a quarterly return (for example, if the aggregate turnover crosses Rs.5 crore during a quarter, then from the next quarter he will not be able to file quarterly returns). If the taxpayer opts to furnish GSTR-3B on a monthly basis.

2. A registered person will not be eligible to opt for furnishing quarterly returns if the last return, which was due on the date of exercising such an option has not been furnished

For example: If the person is opting for quarterly GSTR-3B filing on 1st December 2020, he will need to furnish his GSTR-3B return for October 2020, which would have been the last return due on the date of exercising the

# 3. Deemed monthly/quarterly filing of GSTR-3B

The taxpayer has to follow the above procedure to opt for the quarterly GSTR-3B. However, the GSTN case of registered persons falling in the categories specified in the table below, who have furnished their GSTR-3B return for October 2020 by 30th November 2020, it shall be deemed that they have opted for monthly or quarterly filing as detailed below-

S No.	Class of Registered Persons	Deemed Option	
1	Registered individuals with an aggregate turnover of up to Rs.1.5 crore, who have furnished Form GSTR-1 quarterly in the current financial year	Quarterly GSTR-3B	
2	Registered persons with an aggregate turnover of up to Rs.1.5 crore, who have furnished Form GSTR-1 monthly in the current financial year	Monthly GSTR-38	
3	Registered persons having an aggregate turnover exceeding Rs.1.5 crore and up to Rs.5 crore in the preceding financial year	Quarterly GSTR-3B	

The taxpayers referred to in the SI. No. 2 in the above table can change the default option and opt for quarterly GSTR-3B filing between 5th December 2020 and 31st January 2021.

## 4. How to submit details of outward supplies?

The taxpayers who opted for the QRMP scheme can use the Invoice Furnishing Facility (IFF) which allows quarterly GSTR-1 filers to upload their invoices every month. However, the IFF can be used only when a taxpayer whose turnover is up to Rs.1.5 crore. One should keep the following points in mind before utilising the IFF:

- · The IFF can be utilised only for the first two months of a quarter.
- · The invoices relating to the last month of a quarter are to be uploaded in the GSTR-1 return only.
- · There is no requirement to upload invoices in GSTR-1 if the same has been uploaded in the IFF.
- · The taxpayer has to submit the B2B invoice details of sale transactions (both inter-state and intra-state) along with debit and credit notes of the B2B invoices issued during the month.
- · The total net value of invoices that can be uploaded is restricted to

- The details submitted in IFF will be reflected in the GSTR-2A, GSTR-2B, GSTR-4A or GSTR-6A of the recipients as the case may be.
- The Invoice Furnishing Facility will come into effect from 01.01.2021.

#### 5. How to make monthly tax payments under the QRMP scheme?

The taxpayer has to deposit tax using form GST PMT-06 by the 25th of the following month, for the first and second months of the quarter. The taxpayers can pay their monthly tax liability either in the Fixed Sum Method (FSM) or Self Assessment Method (SAM).

#### Fixed Sum Method (FSM):

The taxpayer must pay an amount of tax mentioned in a pre-filled challan in the form GST PMT-06 for an amount equal to 35% of the tax paid in cash.

S No	Type of Taxpayer	Tax to be paid
1	Who furnished GSTR-3B quarterly for the last quarter	35% of tax paid in cash in the preceding quarter
2	Who furnished GSTR-3B monthly during the last quarter	100% of tax paid in cash in the last month of the immediately preceding quarter

#### Self Assessment Method (SAM):

This is the existing method where a taxpayer can pay the tax liability by considering the tax liability on inward and outward supplies and the input tax credit available. The taxpayer has to manually arrive at the tax liability for the month and has to pay the same in form GST PMT-06. For ascertaining the amount of ITC available for the month the taxpayer can use form GSTR-2B. There are certain instances where no amount may be required to be deposited, such as -

- 1. For the first month of the quarter where the balance in the electronic cash/credit ledger is adequate for the tax liability of the said month OR where the tax liability is nil.
- 2. For the second month of the quarter where the balance in the electronic cash/credit ledger is adequate for the cumulative tax liability for the first and second months of the quarter OR where the tax liability


It is to be noted that a registered person will not be eligible for the said procedures unless he has furnished the return for the complete tax period preceding such month. A complete tax period is a tax period where the said person is registered from the first until the last day of the tax period.

### 6. Due dates for filing quarterly GSTR-3B

The due dates filing quarterly GSTR-3B for the state of Assam shall be 24th of the month succeeding such quarter

# IMPORTANT INFORMATION

Here are all the new rules that come into effect from January 1 2020-21

- FASTag mandatory for all four-wheelers: The Union Ministry of Road Transport and Highways has issued a notification stating FASTags are mandatory for all four-wheel vehicles from January 1, 2021. FASTag will be mandatory for four-wheelers or M&N category of vehicles that were sold before 1 December 2017.
- Positive Pay' system for cheques: The Reserve Bank of India (RBI) has decided to introduce the 'positive pay system' for cheques from 1 January 2021. Under the new rule, re-confirmation of key details will be needed for cheque payments beyond Rs 50,000. The issuer of the cheque has to present information, such as the cheque number, cheque date, payee name, account number, amount, and other details and that bank has to match the details before honoring the cheque
- 3. Contactless card transaction limit hike; In the latest MPC, the Reserve Bank of India (RBI) enhanced limits for contactless card payments from Rs 2,000 to Rs 5,000. This will be effective from 1 January 2021 and will be at the discretion of the user. RBI also increased transaction limits for e-mandates for recurring transactions through cards and UPI from Rs 2 000 to Rs 5 000
- 4. Quarterly GST Return filing: About 9.4 million small businesses are set to come under a simpler, quarterly Goods and Services Tax (GST) return filing facility which will be rolled out from 1 January. From next month, firms with sales up to Rs 5 crore, will need to file only four returns showing the summary of all transactions in the rter under the new regime instead of 12 currently (one filed every month), said a finance ministry official
- 5 °C before making landline to mobile calls. The Department of Telecommunications (DoT) has made it mandatory to prefix °C before a number for making landline to mobile calls, effective from January 1, 2021. The ne after the sector regulator, Telecom Regulatory Authority of India (Trai) recommended the move to ate enough numbering space for telcos.

DOT in a notification said the fixed-line users will soon begin hearing the announcement apprising them of the move. The message will be played whenever a fixed-line user will dial to a mobile number without prefixing '0'.
